No items will be held, no reserves are established, and all willing bids need to be paid within 24 hours of notification of winning bid. Bids must be paid by certified funds check or money order (no cash, no personal checks) to the City of Eutaw Alabama.

All bids submitted must be in a sealed envelope with the following form completed. No late bids will be accepted. All bids must be turned into the City of Eutaw City Clerk's Office no later than 8am on September 28th, 2021.

A \$5, non-refundable, bid fee must be included with each bid submitted. Your bid is not eligible if the bid fee is not included with the form. All bid fee's must be in a certified funds check or money order (no personal checks, no cash).
